HOW DO YOU DECIDE IF I'VE PASSED OR FAILED THE PRACTICAL EXAMINATION?

Your overall practical examination result is determined using a partial compensatory test scoring model.

The key points of this type of scoring model are:

- 1. similar stations, tasks, and skills are grouped into clusters
- 2. your overall result is based on your performance in each cluster
- 3. you must pass all seven clusters, in one attempt, to pass the practical examination.

HOW AM I SCORED FOR A STATION OR TASK?

- Your performance in each station or task is assessed by trained and calibrated examiners against 15 assessment critera relevant to that station or task.
- You will receive one of four possible grades for each assessment criterion: very good, satisfactory, borderline, or unsatisfactory.
- Each grade relates to a numerical score of 3, 2, 1, or 0 respectively.
- The scores for each criterion are added together to give a score between 0 and 45 for each station or task.


HOW DOES MY STATION OR TASK SCORE RELATE TO A PASS OR FAIL MARK?

- The passing score for each task or station is set using borderline regression analysis.
- To pass a task or station, your score must be equal to, or exceed, the passing score for the task or station.

HOW DO YOU DECIDE IF I HAVE PASSED OR FAILED A CLUSTER?

- Your scores for each task or station within the cluster are added together to determine your **combined cluster score**.
- The pre-determined passing scores for each station or task within the cluster are added together to create a combined passing score for the cluster.
- To pass a cluster, your combined cluster score must be equal to or greater than the combined passing score for the cluster.
- It is your combined cluster score which determines whether you pass a cluster, not the number of tasks or stations you pass (see figures one and two).
